Description: Embedded audio processing module (printed circuit assembly) for use in electronic musical instruments and audio equipment.

3. STATUS UNDER REACH

The product identified in Section 2 is an article within the meaning of Article 3(3) of Regulation (EC) No 1907/2006. It is neither a substance nor a mixture, and under normal and reasonably foreseeable conditions of use it is not intended to release any substance. No registration obligation under Article 7(1) therefore arises in respect of this article.

4. SUBSTANCES OF VERY HIGH CONCERN

Qu-Bit Electronix, Inc. declares that, to the best of its knowledge and based on information obtained from its supply chain, the product identified in Section 2 does not contain any substance included in the ECHA Candidate List of Substances of Very High Concern in a concentration above 0.1 % by weight (w/w) of any individual article contained within it.

This declaration is made against the Candidate List as updated by ECHA on 3 June 2026. The Candidate List is revised approximately twice each year; this declaration is reviewed and reissued following each revision.

5. RELATED OBLIGATIONS

- Article 33(1): as no Candidate List substance is present above 0.1 % w/w, no communication of safe-use information is required for this product. Should this change, recipients will be informed in accordance with Article 33(1).
- Article 33(2): information under Article 33(1) will be supplied free of charge to any consumer on request, within 45 days of receipt of the request.

- Annex XIV (Authorisation): the product does not contain substances requiring authorisation for the uses concerned.
- Annex XVII (Restrictions): the product complies with the restrictions on the manufacture, placing on the market and use of certain dangerous substances, mixtures and articles, including entry 27 (nickel release) and entry 50 (polycyclic aromatic hydrocarbons).
- SCIP database: as no Candidate List substance is present above 0.1 % w/w, no notification is required under Article 9(1)(i) of Directive 2008/98/EC.

6. BASIS OF THIS DECLARATION

This declaration is based on declarations of compliance and full material declarations obtained from component manufacturers and franchised distributors covering the product bill of materials, together with supplier declarations covering the bare printed circuit board, assembly process materials, packaging and accessories. The supporting documentation is retained by the manufacturer and is reviewed at each bill of materials or hardware revision and following each revision of the Candidate List.
